If any provision in the Contract is declared void or unenforceable by any court or other body of competent jurisdiction or is otherwise rendered so by any applicable law, such provision shall to the extent of such invalidity or unenforceability be deemed severable and all other provisions of the Contract not affected by such invalidity or unenforceability shall remain in full force and effect.
- 16. In respect of Goods originating in the United States of America, the construction, validity and performance of the Contract shall be governed by the laws of the State of Michigan, except its rules as to choice of law. Any controversy or claim arising out of or relating to the contract, not resolved between the parties by following an Alternative Dispute Resolution procedure, shall be settled by arbitration in accordance with the rules of the American Arbitration Association (location Detroit, MI), and judgment upon the award may be entered in any Court (state or federal)

having jurisdiction thereof.

17. In respect of Goods originating in the United Kingdom, the construction, validity and performance of the Contract shall be governed by the law of England and Wales and the parties agree to submit to the exclusive jurisdiction of the English Courts.

 If there is any conflict between the provisions of the English language version of these Conditions and any version translated into another language, the former shall prevail. GR 11018-02
